

PRESIDENT'S REPORT 2019

God has certainly abundantly blessed Gloria Dei in the past year. From the dark cloud of uncertainty about our future, God has led us on a slow but steady path toward a brighter tomorrow. Both council and the planning committee continue to seek new goals for the coming year. Those are a few of the highlights.

With the good news comes some caution. In no way are we in a position to 'rest on our laurels'. There is much more work to accomplish. We need the continued support of everyone to maintain where we are and move even closer to some of our long-range goals. New members would be welcome for all our committees. While more people volunteered this year, it is still a small minority of our membership. We can do better in this area. Financial support will be critical as we stretch ourselves in new and upcoming needs. Continued prayer that we discern God's plan for us as we move forward. Support as we form a Call Committee. Please stay vigilant in your attendance, welcoming visitors, financial stewardship, and prayer.

Like everyone else, I thank God for His gifts and pray that we stay close to Him and the desires He has for the people at Gloria Dei.

PARISH MINISTRY REPORT 2019

As Director of Ministry, I help keep an eye on both the operational and ministerial sides of Gloria Dei. The year of 2019 was an adventurous ride for Gloria Dei. The number one operational goal was to successfully make the budget. This goal was made, with thanks to the entire congregational family. As a result, the ministry of Gloria Dei continues to thrive. The upcoming year of 2020, will have some additional challenges, as we look at our "Growing Edges". The summary printed below will support this belief.

Financially: We made our budget plan! YAY!! Our income for general expenses was \$106,157, with expenses of \$105,972. Our Capital Campaign was successful for the third year in a row. We asked for \$10,000 and raised \$12,844. I would be remiss, if I did not applaud both the congregation for their generosity, but all the groups that helped support and supplement our financial goals: Brat Fry, Bake Sales, Dinner Theater, Women's Retreat, Lenten Soup Suppers, Empty Bowls, Rummage Sale, and others.

Programming: During 2019, Gloria Dei continued a wide variety of activities and Out Reach ministries. Gloria Dei held their Annual Rummage Sale again, Dinner Theater, Vacation Bible Camp, Fall Fun Fest, Gingerbread House – Women's Retreat, and the semi-annual Highway Clean-Up. Our Youth Group, under the leadership of Becca Zimmerman started a youth project called "Super Santa Soup Supper", hosted movie nights, and Mystery Parties. The "Ministry Opportunity Table" has helped keep projects visible. Again for 2020, any project undertaken, must have a project leader and project helpers in order for the project to be undertaken. Also, for any project that uses the kitchen, must have a clean-up committee. If there is insufficient interest, a project or activity is canceled.

Ministry: For 2019, Gloria Dei continued utilizing the ministry of the Reverend Jim Liddle to be our Regular, Intentional Supply Pastor. Jim has embraced his role with Gloria Dei, with an openness. The ministry model we are using, is not utilized anywhere else that I know of; however, with the help of the congregation, we have made it work and has helped lead to some growth. Jim's duties are more than preaching, but less than what would be expected from an Interim. Jim has been faithfully visiting our shut-ins, our inactive members, and our less-than-active active members.

Liturgically: Utilizing Sundays and Seasons, the ELCA sponsored lectionary calendar, my mission is to create meaningful worship services that primarily uses our Low-Liturgy format, Setting 5 from the With One Voice Songbook, and Setting 2 from the Lutheran Book of Worship. Special liturgies are introduced for special services as necessary, at my discretion, with the input from the Worship and Music Committee.

Hopes and Dreams:

This year will be test the character of Gloria Dei. Everything done over the last two and one-half years has been with the plan and intention of rebuilding and regrowth. With continued thanks to the congregation and church council for continuing to support ideas and concepts that are "outside the box".

As I look at the upcoming year, I see several things that really should happen:

Again, achieve the income required to support the general operating budget, without relying on brat fries, bake sales, dinner theater, and other fund-raising events.

Use fund raising events to support various local and regional needs ministries. While we give thanks to God for the good things we have, we are asked to look outside the doors of Gloria Dei for opportunities to serve and minister.

Support the formation of a Call Committee. Without a Call Committee, Gloria Dei cannot move forward.

Develop training opportunities for new lay assistants and lay leaders.

Continue to utilize electronic media for on-going communication.

Create a training opportunity for others who would like to learn more about Lutheran Liturgy and setting up worship services for Gloria Dei.

I will be pulling back from some of the tasks that I embraced over the two and one-half years, while at the same time, writing more process procedures that can be followed. One of our "Growing Edges" is that Gloria Dei is still a "congregation in transition". Between Jim and me, we have filled many gaps in our church operations; however and particularly, during a time of transition, the congregation is expected to become more involved. And while there is some evidence of that, a little bit more is needed. I will specifically address those needs within the next couple of months.

In conclusion: It has been a joy to watch Gloria Dei regain some of our inner strength once again. It has been a privilege to pray with, worship with, and be accepted at Gloria Dei, where we are work on how to "Make Christ Known". And remember that God does love each and every one of you and...

CAPITOL CAMPAIGN REPORT 2019

2019 was the third year of our dedicated Capital Campaign drive. Our goal was to raise \$10,000. Thanks to the generous giving and bake sale fund raising, we sent Mission Investment, (our mortgage holder) \$12,843.72. This payment in addition to our regular payment reduces the mortgage term. The current rate is 4.625% and the expected maturation date will be 10/1/2027.

SUNDAY SCHOOL REPORT 2019

Sunday School meets after worship from September through May. There are two classes: pre-K to 1st grade and 2nd grade and up. There are approximately 6-10 kids for Sunday School each week. Both groups switched to a curriculum from Sparkhouse called Whirl Classroom. It teaches kids about the Bible with concepts designed for their level and also uses short videos to engage the kids. On December 22, 2019, 17 Sunday School kids presented their Christmas program.

VACATION BIBLE SCHOOL REPORT 2019

Vacation Bible Camp 2019 was a success! There were about 18 campers throughout the week of July 15-19. The kids really enjoyed each other and grew in their faith and service. A big thanks to the three counselors from Crossways: Megan, Morgan and Teressa. The campers learned several new songs and focused on the theme of "Transformed Community: God's Agent of C.H.A.N.G.E.." The kids were also involved in several service projects throughout the week. Boxes of cereal were collected and delivered to Rays of Hope in Kiel. The campers walked to Oak Creek Assisted Living to sing songs perform skits, and play bingo with the residents. They made crafts that were given to the Meals on Wheels program to distribute. At worship on Wednesday evening, the kids showcased a skit and some of the songs they learned. In addition the campers learned about animal care from Ian & Sanja Arndt. Thank you to the VBC leaders Laura Hoban, Becca Zimmerman, Tina Puro, and Colleen Allee and to the teenage helpers. Thank you to everyone who donated food for the campers during the week and to all who donate money to noisy offerings all year long. The kids really grow in their faith and friendships with each other throughout the week. VBC 2020 is already scheduled for July 13-17 with Crossways.

WORSHIP AND MUSIC REPORT 2019

Members of this committee for 2019 were: Rev. David Kohls, Barb Spiegel, Doug Everson and Raeline Springstroh. Ruth Camomilli attended the meetings as a liaison between the council and committee. Once again, we planned the services for all the special liturgical seasons, decorate the church, changed out the Alter Linens and banners per season and discussed music choices. This committee also orders the flowers for Easter and Christmas, coordinates all the supplies for communion, Baptisms, Confirmation and Weddings. Barb assigns all the worship assistants for every Sunday including Readers, Greeters, Ushers, Communion Setup, and Acolytes. In 2019, we purchased more children's bibles, candles, and banners to be used for our services. Doug and Dave took on the task of recording music in case Doug is not able to make a service to play for us in person. We are looking forward to 2020, with the same committee members as well as Nealey O'Brian.

BUILDING AND GROUNDS REPORT 2019

Routine maintenance and upkeep of the church and property continues. Thanks to the generous support from the congregation and Scrip, a new furnace and air conditioner for the wing where the offices and Sunday school rooms are located was able to be installed this year. Three of the furnaces needed maintenance and were able to be fixed. Terry Erickson replaced all the filters in the furnaces in October 2019. (Thank you Terry Erickson!) The urinal in the men's bathroom was also repaired this year. (Thank you Hugh Springstroh!)

There is a rodent problem especially in the church kitchen and steps are actively being taken to eradicate this problem.

The parking lot is scheduled to be resurfaced in spring 2020. Thank you to the Dinner Theater for their support on this project.

The service door on the garage will be replaced in spring 2020. (Thank you Darryl Schaefer!)

Projects on the radar include repairing the fascia/soffits on the exterior of the church, removal of the mildew that has been noted on the exterior of the church, and painting the interior of the church.

A huge thank you goes out to Joe Muellenbach for his continued service with lawn care and snow removal.

The Building and Grounds Committee has committed to starting to meet on a more regular basis and putting an action plan together on how to move forward with completing tasks.

Thank you to the talented and willing group of guys who make up this committee.

OUTREACH TEAM REPORT 2019

Outreach Team meets quarterly to facilitate and encourage projects that reach out to our members, our community, and the larger world. Some of our projects overlap with those of Fellowship Committee. All Gloria Dei members are invited to attend our meetings. Current active team members include Mike Hetzner, Coleen Allee, Dianne Fett, Becca Zimmerman, Raeline Springstroh, Dave Kohls, Jim Liddle, and Roxie Ruechel, Council Liaison.

Letters introducing Gloria Dei to new families in local communities are sent out using Zillow to identify people who have bought homes in the area. (Raeline)

Visitor Liaison—Greeters are being trained to identify visitors at worship service each week and encourage them to sign the guest book on the lectern near the worship are entrance and take a brochure. Outreach Team members also do this. Approximately eight loaves of bread with a welcome note were then delivered to visitors' homes. (Raeline)

Cookies to college kids were packaged and mailed March 3 and November 3.

Meals to members in need—Using a \$250 grant from Thrivent, food supplies are being made available with recipes for people to deliver to Mike and Carol Field. (Annette Pleshek, Dianne, Brenda Kobs) We also discussed reviving a program to bring meals to any members who are ill, recovering from surgery, have new babies, or are grieving.

Highway Cleanup—10 people helped out May 25 and October 9. (Mike)

Food Drive items are collected at worship the third week of every month and delivered to local pantries.

Bale Sales this year in May, June, July, and August totaled \$3090.68, with \$2,781.61 to capital campaign, \$309.07 to benevolence, and \$100 to change. (Pat Jensen)

Rummage Sale September 13, 14, 20, 21 totaled \$1,753.50. (Ruth Camomilli)

Brat Fry April 27 raised more than \$500 with \$50 donation going to New Holsten food pantry and the rest to Gloria Dei pastor fund for purchase of altar supplies. (Hugh & Raeline Springstroh)

Road America volunteers—2-4 people participated June 4 and July 2, raising money for general fund. (Roxie)

Future Plans

- 1) Tables of Eight are being planned for the coming year.
- 2) Empty Bowls is being planned for February 23.
- 3) AED at GD? Contacting local agencies—likely can be obtained at no cost but may require some training of members.
- 4) Pentecostals are sharing our building for worship services Sundays at 11:00. Planning a welcoming reception for them, perhaps a casserole luncheon after their service.
- 5) Sanctuary Church (declared by ELCA)—We already have gift cards available for people in need. Jim will talk with other local churches at ecumenical group about coordinating activities.
- 6) Invite close neighbors, especially those new to your neighborhood, to GD. (Jim)

Treasurer's Annual Report 2019

A summary of Gloria Dei finances is given on the following pages. The first page shows the income and expenses compared to the budget and shows the proposed budget for 2020. The second page highlights the activities of the Capital Campaign, the mortgage debt, savings account, Memorial fund and the checkbook. The third page gives information on the benevolence giving of the congregation and the summary of the funds specially raised for building projects.

The 2019 budget had predicted expenses to exceed income by \$14,885. However, the congregation increased giving more than predicted and the year ended with income exceeding expenses by \$185. Overall, the expenses were about \$1,000 more than budgeted. However, there was \$1,391 spent on furnace repairs.

The proposed 2020 budget income is based on the received pledge cards and looking historically at the amount of funds received that are not pledged. The income does not include any fundraiser activities nor relying on other income sources such as SCRIP. Gloria Dei receives income from the Thrivent Choice program from congregation members that have accounts with Thrivent and make use of the program. A small amount is factored into the budget as it has provided income for several years.

The proposed 2020 budget expenses include an increase for all staff (Supply Pastor, Director of Ministries, Lay Minister, Organist/Choir Director and Secretary). The building and grounds budget has increased to account for at least a small amount of unpredictable expenses. Also, the grass and snow expenses has averaged \$1,900 over the last 7 years and this was not accounted for appropriately for 2019. A new line item for church cleaning has been added to the budget that has not been present in years past. However, the volunteer-based effort over the last few years has been sporadic and not sufficient to maintain the building. Overall, the proposed 2020 budget has expenses exceeding income by nearly \$5,000.

The 2019 Capital Campaign raised \$12,843.72 which was greater than the \$10,000 goal. The money raised on the campaign went toward paying down the mortgage.

In 2019, the congregation raised \$750 to spend on benevolence through the bakes sales, rummage sale and working at Road America with the Elkhart Lake Lions. As noted, there are many other benevolence projects that did not get captured in this total.

Outside of the budget, the congregation has raised money to be used for special building projects. A new furnace was installed this year from this effort. Some money from the SCRIP account and from the savings account were also used to fund the furnace. The next special building project that has been identified is to resurface the parking lot. There was \$3,308 remaining at the end of the year to go toward that project. This is planned to occur in spring or early summer. Also, the Dinner Theater has offered to match funds for the project which is not included in the total above.
