At the annual meeting, Gloria Dei passed a budget that projected a shortfall for 2021 of over \$17,000. This report is intended to keep the congregation informed on overall budget on a monthly basis. Please reach out to me if you have any specific questions. In June, the congregation set a goal of raising \$15,000 for the building staining project. \$17,125 were raised. The work was completed with \$14,853.

For December, the general income was \$2,970 more than general expenses. At year end, income exceeded expenses by \$5,089 which includes the extra \$2,272 from the building project.

The year end report is given in the annual meeting.



Consideration of Remote Church Services for the rest of January—Sue reported that the Wisconsin Council of Churches has advised all worship services be only virtual for the next 4-6 weeks due to the surge of Covid. Calumet County January 10 reported a record for the number of new cases, risk levels critically high. Some classrooms in Chilton have only half of their students in class. Council decided, given the relatively low number of people attending worship in person, our current policy provides adequate safeguards. Members are advised about the risks, and the availability of attending worship online.

Report of Nominating Committee—Mike reported that Laura Hoban is assisting with calls to members for nominations. Council discussed potential nominees. The list will be finalized soon for the annual meeting.

Preparation for Annual Meeting—Annual meeting January 30 will be held in person and via Zoom with much of Council assisting; trial run January 23.

Committees and Reports as Needed

- 1. Fellowship/Outreach—Brenda: hygiene items continue to be collected for Salvation Army
- 2. Property—Bryce: water situation is improved. Full report for annual meeting.
- 3. Stewardship/Long Range Planning—Nealey: pledges are coming in.
- 4. Worship—Anne: Wednesday evening Lent services will begin March 2.
- Youth/Christian Education—David: a children's Christmas program was presented December 19. Four confirmation students are meeting with Pastor Jim regularly.

Calendar Update—Annual meeting January 30. Next Council meeting February 8, agenda to include capital campaign, staff salaries, and consideration of a March Council retreat.
