

Gloria Dei Lutheran Church Annual Congregational Meeting January 31, 2021

Welcome—President Karen Ebert. A quorum of over 24 members was confirmed present for this Zoom meeting.

Opening Devotion—Reverend Roald Harswick

Approval of Minutes—A motion was made by Julie Schaefer, seconded by Jennifer Lecker, and carried to accept the minutes of the annual congregational meeting of January 26, 2020.

Approval of Agenda—A motion was made by Jennifer Lecker, seconded by David Hoban, and carried to accept the agenda for this meeting.

Budget Presentation and Approval—David Hoban, Treasurer. Following David's presentation there was a discussion of the budget, including concerns about a \$17,352 shortfall in expected income vs. expected expenses. Currently we have a \$21,000 balance in our checkbook that would cover this temporarily. A suggestion was made to divert \$10,000 budgeted for capital campaign, which goes to reduce our mortgage balance, to the general fund. A motion was made by Joe Janicek, seconded by Dianne Fett, and approved to accept the budget as presented.

Business— Approval of updated constitution. Following a summary of the updates presented by Karen Ebert and Dick Welsch, the updated constitution was approved by vote, following a motion by Kathy Welsch, seconded by Annette Pleshek. The changes were largely required by Synod, and included notification of meetings can be done by email, the inclusion of the bylaws in the constitution, and \$10,000 expenditure can be approved by Council.

Update from Call Committee. David Hoban reported that the committee met earlier in the year and is waiting for a list of candidates from Synod.

Nominations and Election of Council Members and Officers—The slate was presented by Karen Ebert. There being no nominations from the floor, the slate was approved by vote following a motion by Dianne Fett, seconded by Tara Leithold. The elected officers and Council members for 2021 are:

President's Report 2021

Another year of the COVID pandemic saw many changes at Gloria Dei. In April, we said goodbye to our Interim Pastor Roald Harswick. In May, we graciously welcomed back Pastor Jim Liddle to be our dedicated supply pastor but we had to move our services to 8:00 a.m. as the congregation he also is serving at changed their worship time.

We started worshiping in church once again in January with a few restrictions in place. Before Pastor Harswick left, confirmation for four of our young members was held. In October, some of our young members made their 1st Communion.

The work and service of Gloria Dei continues. As possible, our committees still meet. Stewardship is wrapping up our annual pledge drive. Worship has created meaningful opportunities to gather and praise God. The Call Committee continues to be active in finding a part-time/shared Pastor. The Property Committee has been very active especially with collecting water samples with assistance from the Department of Natural Resources. In December, the Department of Natural Resources contacted the Property Committee indicating our water is once again safe.

In June, a congregational meeting was held to consider staining the church for over the \$10,000 earmarked amount as stated in the Constitution. Members of Gloria Dei approved this with the caveat that the amount is collected via fundraising. Gloria Dei raised the necessary funds in one week for which I am very grateful.

Gloria Dei maintained its desire to service the community in Making Christ Known through large contributions to food banks and assisting the Salvation Army in Chilton with their Toys for Tots program. For God's Work, Our Hands day, Gloria Dei provided school supplies for the New Holstein High School.

All this good news does come with challenges. In-person opportunities to worship and viewers of virtual services appear to be down. We continue to ask for volunteers to keep the work and spirit needed to maintain us through the coming months and year, with little response. Pray faithfully that you can say I can help now, not I will think about it when we return to normal. The Council wants nothing more than to put us back on the road to moving forward as a strong and vibrant body of Christ.

It has been a pleasure serving Gloria Dei.

STEWARDSHIP REPORT 2021

Over the last number of months I have been amazed at how our church members have adopted and made innovated adjustments to daily lives. Adjustments to comply and cope with challenges that few if any could have anticipated. My thoughts were on Stewardship along with long range planning and a whole host of activities. The committee met only a couple times in person. Communications were mostly on line. Stewardship covers a lot of ground. So where do we go from here?

There is a paper copyright 1996 by the Evangelical Lutheran Church in America which has given permission to churches to share with their congregations. The document simply lists titles of the areas of stewardship. I will summarize. Stewardship is: of Self, of Creation, of Possessions, of God's Mysteries, of Talents, of the Future, of Ideas, of Money (investing, saving, giving "to charities, to family/friends, to church, to political parties, to strangers"), sharing, managing, caring, shepherding, growing, developing, taking, increasing "earning" protecting). Stewardship is: of Family, of Citizenship, of Knowledge, of Food, of Forgiveness, of Time, of Work, and of Joy.

"Giving" gets favorable attention. Our treasurer has shown us a possible direction on giving to help support a future pastor along with a plea to increase giving to support all the other areas of Stewardship. May we adapt and make innovated adjustments to make it so.

Thank you to Treasurer David Hoban and Council member Nealey for your committee work.

Over the last several years, Gloria Dei has been a congregation in transition. WIth the reduced Pastoral budget during this time there has been a focus on paying down our debt through the Capital Campaign. Since June 2017, the congregation has raised \$49,628! The mortgage balance has gone from \$263,100 in June 2017 down to \$138,200 as of October 1. This puts Gloria Dei in a much better position to transition back into a settled Pastor. Congratulations and thank you to all.

This year the stewardship efforts need to prepare Gloria Dei for the transition into a settled Pastor. The extra focus towards the Capital Campaign now needs to be dedicated to our Pastoral leadership. Over the last several years, the Pastoral leadership expenses have ranged from \$1,800 per month up to \$3,000 per month. Currently, we are at the lower end of that range. A year ago when there was an interim Pastor through the synod it was \$4,000 per month. That was the value included in the 2021 budget. Gloria Dei's income was not able to match expenses during those months with an interim Pastor. Looking to the future, a part-time settled Pastor is estimated to be \$3,500-\$4,500 per month. Please prayerfully consider the anticipated increased costs when determining your pledge for 2022. David

Gloria Dei Lutheran Church is doing OK, considering the current situation. COVID is still taking its toll on most of the churches in the area, and Gloria Dei is no exception. Many families are worshiping via Zoom or Facebook. That is fine, but it tends to make a smaller attendance at church worship and less participation in the worship service than before.

The time of the service may also have something to do with that. I know that an 8:00 a.m. worship time is not what most members would like. When I told your governing body that 9:00 was not possible due to a previous commitment to another church, I was very surprised (pleasantly so) when they offered to move the service to 8 a.m.

I appreciate all the people supporting me in the worship service. There are several who run zoom and face-book week after week. There are greeters and ushers and readers and song leaders. There are even people to preach if I take a vacation or get sick. I appreciate them all.

Beginning on March 2, which is Ash Wednesday this year, I would like to offer an alternative time of worship. Gloria Dei used to have an additional Wednesday evening service as well as a Sunday service. This year, at least for Lent, we will be restarting that tradition. If there is interest in continuing those services after Lent, we will continue them. Note: this will not be a repeat of the Sunday sermons, this will be a separate, different service.

As well as my Sunday church duties, I am keeping busy. I am leading a confirmation class of four young people. We meet on Saturday mornings. I also keep my Wednesday office hours. Currently I visit two members or relatives of church members who are in supported living arrangements.

I will be turning 74 in August. I am not sure how long I will want to keep going as supply pastor for two churches. But for now, I am enjoying my work at both churches. I tried retiring a couple of years ago, and I got bored after about two months. I like being a pastor and preacher and expect to hang around for a while longer.

BUILDING AND GROUNDS REPORT 2021

The current property committee consists of the following members. Dick Welsch, Terry Erickson, Randy Schumacher, Darryl Schaefer, Craig Heller, Eric Puro and council representative Bryce Larson.

The property corresponded mostly via e-mail for the 2021 year. We did meet twice early in the year to finalize our staining project. Yes the big aspect for Gloria Dei this year for the property committee was submit bids and award a bid for CertaPro to stain our church and our shed. CertaPro submitted the lowest bid and were awarded the contract. The council would not approve the project until sufficient funds were raised. Thank you to stewardship and others for spearheading a fund drive that reached our goal of \$15,000 within two weeks. The job was completed in September. A huge thank you to all members of Gloria Dei for stepping up and making this major project a reality. When God is asked to work with us, we become more generous. The facility really needed the facelift as we were nearing the point where more costly repairs would be needed.

Property committee members worked with the DNR for several weeks to take water samples as our water supply was deemed unsafe for a period of time. Our last 9 samples over a two-month time period have been safe. We have been running several taps indoors and outdoors periodically to keep our system flushed. That has made the difference. We have received a list of items we can utilize for the future to keep our system flushed. The property committee is developing a set of protocols and time tables that we will use to keep our system running safely. We did discover that the pressure gauge on our tank does not work and we will address that issue.

This spring our septic system was pumped out, inspected and passed. This is done every three years. We have 3 cells as part of our system and the 3rd cell has the pump which pumps the waste under our side street and into our drain field on the south side of that street.

We are hoping for an uneventful property problem year. We on the property committee want to thank the members of the congregation for their rapid and significant responses to the needs of the facility.

We have a new waste handling company and we need to update our schedule to jive with the new firm's schedule. Bryce Larson has agreed to serve as the council representative for property the next two years.

I want to thank the members of Gloria Dei for supporting the needs of our facilities and a thank you to the members of our committee who work diligently on your behalf to have a safe and well-maintained church home for you to worship at.

Treasurer's Annual Report 2021

The following 4 pages contain the financial information for 2021 and the proposed budget information for 2022. The report below describes the information contained in the report.

The total account status for Gloria Dei is shown on page 1. This brings together the operating budget, benevolence, Capital Campaign, and the building projects. This is the final income versus expenses for the year. The church was ahead by \$5,088.63 for the year.

The summary of the operating budget for 2021 and the proposed budget for 2022 are on page 2. As a whole the operating budget was nearly \$2,817 ahead. However, there are many factors that need to be highlighted.

There are several things to point out on the income side. The overall operating income was about \$1,400 more than predicted. The offering revenue was down slightly but was offset by an increase in special offerings (Easter, Christmas, etc.).

There are several things to point out on the expenses side. The original 2021 budget was set based on having an Interim Pastor from the synod and predicted a \$17,342 shortfall. However, in May, the church transitioned from the Interim Pastor back to an intentional supply pastor. This was a savings over \$2,000 per month. Over the course of the year, the electric bill increased significantly. There was some savings realized in the gas and phone/internet expenses. The phone/internet went down after changing over to Mercury Network in January.

Page3 shows the summary of benevolence and building projects. \$100 was donated to the synod mission support. There was one building projects in 2021 to finish the painting and staining of the building. This was completed at a cost of \$14,853. In July, \$17,125 was raised to support this project. Thank you to all who donated! There is \$2,272 leftover for future use.

Page 4 summarizes several accounts. The Capital Campaign ended the year with \$3,070. Thank you to all who have supported. This money is used to pay down the mortgage on the church. The mortgage information at the beginning and end of the year are given. Over \$50,000 has been raised for the Capital Campaign since it was started in 2017! The mortgage has gone down from \$263,150 to \$130,000 during that period. Going into 2022, there will not be a goal for the Capital Campaign. It is desired to transition this giving into the future ministry budget as we plan to obtain a settled part-time pastor.

The only money going into the savings account is the rent from the Pentecostals. However, halfway through the year it was decided to put that money into the checking account instead. The Memorial Fund has \$1,101.55. There were \$305 of donations and no money was taken out of the account this year. The account balances for the checking account, savings account and Memorial fund are given for the beginning and the end of the year.

2022

The 2022 budget is highly dependent on the future of the ministry at Gloria Dei. It is estimated that a settled part-time Pastor will cost approximately \$48,000 per year. That is nearly a \$28,000 increase from the current situation of an intentional supply Pastor. The stewardship campaign attempted to highlight the need of increased giving to support our future ministry. The proposed 2022 budget is given on pages 1 and 2. It is built using our ministry levels of today. However, the last line on page 2 shows the corresponding net budget with a settled part-time Pastor. We don't know when the next candidate will be presented to the call committee. However, as a congregation we need to plan to eventually support that level of sustained ministry expense.

The operating expenses are based on actual expenses from 2021. Some categories are increased (electric, insurance) while some are decreased (cleaning, gas, Lay Ministry, Sunday School). Overall, the building and grounds budget is decreased \$1,500. This is based on the 2021 actuals. There are other expenses within the office and worship expenses that were reallocated into the sub-categories to better capture the expenses.

The offering revenue prediction of \$98,000 is based on the pledges that were return during the Stewardship drive and past history of the amount given that is not pledged. \$51,484 pledged by 17 giving units. \$24,304 estimated by giving units who have not pledged but are simply givers. \$18,354 estimated by giving units who have not pledged but donated in 2021. Loose change (cash) adds into the final estimate.
