For January, the general income was \$584 more than general expenses. Year to date, income exceeds expenses by \$834. (Note the two columns are not the same due to way we track and pay payroll taxes. The year to date averages out the payment each month where we actually pay the tax bill quarterly. Even then, they are slightly off since we pay the quarterly taxes 3 months in the rear.) January included the quarterly payroll tax bill (\$758), the quarterly banking software bill (\$222) and the yearly copy machine service (\$400). January did not include the monthly insurance bill (\$266). This arrives at the end of each month and sometimes ends up being placed tracked two in one month.

Covid Precautions Update – Discussion was held. We will keep our current recommendations for safety as Calumet County is still in the CRITICALLY HIGH category for level of COVID-19 disease activity according to the Calumet County Health Department (2022/02/07). We are averaging 20-25 members in person and 2-6 members participating online by Facebook during Sunday services.

Capital Campaign – We are currently making our budget, but the congregation is not giving enough to support a part-time pastor at this time. Discussion was held on how to pay down our mortgage which would facilitate enough funds for a settled part-time pastor. Mortgage may be paid off in 5-6 years. The Stewardship Committee will meet and make a recommendation to Council.

Staff Salaries -

Pastor Jim Liddle - \$1750/month – Sellen made the motion to pay an extra \$175 per Lenten Service since current contract did not include this expectation. Kobs seconded. Motion approved.

Organist *Doug Everson* – Songs have been recorded. No change at this time.

Secretary Ann Martin - \$13.25/hour - Tabled a motion for \$0.25 increase till next month.

Committees & Reports as Needed

- 1) <u>Fellowship/Outreach</u>— Food & hygiene product drive is ongoing. Post cards to encourage attendance may be written. Ideas to encourage new members welcome.
- 2) Property— Some items and thoughts for the coming year...
 - Have the property committee try to meet for a short planning meeting, preferably following a Sunday service or other convenient time.
 - Report to the council property committee items of concern or facility issues needing attention.
 - Contact our lawn care and snow removal providers to seek any input or concerns they may have.
 - Contact the New Holstein recycling center to check on ability and or timing for recycling our two electric organs we need to remove.
 - New chains and padlocks for our 3 cells or our septic system.
 - Put in a permanent non-vegetation area around our exposed well cap, per DNR suggestions.
 - We now have Ann our administrative assistant assisting with the flushing of our faucets and water taps on a regular basis.
 - We typically need or use several bags of mulch to fill in the bare areas and add color to the areas we mulch.
 - Suggest we find a time and volunteers to window wash all the lower level windows inside and out. Spring is a good time to tackle this task.
- 3) <u>Stewardship/ILong Range Planning</u>— Members will meet soon to discuss finances.
- 4) <u>Worship/Music</u>— Members will meet soon to discuss Lenten services (7 last words). Ash Wednesday is March 2nd.
- 5) Youth/Christian Education none

Capital Campaign 2022

The stewardship drive this fall stressed the importance of looking forward to the future and increased expenses that a settled part-time pastor will bring. Gloria Dei needs \$1,500-\$2,000 a month more per month compared to the average of 2021 to sustain a settled part-time pastor. The budget for 2022 presented two scenarios: 1) continue as is or 2) call a part-time pastor at some point during the year. As described by the call committee update, we do not have a candidate to present in the near future. Therefore, we would like to resume the capital campaign effort in the near term. This will help put Gloria Dei in a better position in the years to come.

The capital campaign effort was started in 2017. Over \$50,000 has been raised since that time to reduce the mortgage debt. The mortgage is down to less than \$130,000 and the maturation date is October of 2027. Congratulations! The end is within site. This puts Gloria Dei in a great position as we look forward. Please prayerfully considering donating extra toward the capital campaign effort. Every extra donation will reduce the time to be debt free and allow us to better sustain our ministry budget in the years to come. The council will also be considering to use extra 2022 revenue toward this effort.

Minutes of the Annual Congregational Meeting, January 30, 2022

Gloria Dei Lutheran Church, New Holstein, Wisconsin

Call to Order—There being a quorum of over 24 members in attendance (28 including 5 via Zoom), the meeting was called to order at 8:45 am by President Julie Schaefer.

Opening Devotion —Rev. Diane Cayemberg, visiting pastor

Approval of Minutes from January 2021–The minutes were approved with the addendum of "Respectfully Submitted, Michael Hetzner."

Budget Presentation and Approval. —David Hoban Treasurer, summarized the budget of 2021, noting that we had more income than expenses due to the reduced pastoral expense of the regular supply pastor, Rev. Jim Liddle, after the departure in April of the interim pastor, Rev. Roald Harswick. In 2022 we once again will have budget uncertainty. If our current pastoral situation continues, our projected budget for 2022 indicates a surplus of about \$19,000. Whereas, if we were to call a settled halftime pastor now, we would have a deficit of about \$8,400. There was a question why the scrip account is not included in the general budget. This continues as a separate "rainy day fund", at the discretion of Council, should it be needed. Following a motion by Anne Sellen, seconded by Dick Welsch, the budget was approved as presented.

Update from Call Committee—David Hoban reported that after the Call Committee was appointed in 2020, the Bishop referred a pastoral candidate to us in July 2021. The Committee had several promising interviews with the candidate, but were unable to refer the candidate to the congregation due to the financial hardship this would appear to have imposed on the congregation. The candidate was freed to seek other opportunities and may have accepted another post. The Committee will continue its efforts, including investigating, with the help of staff at Synod, sharing a pastor with another congregation. Annette Pleshek suggested we all need to be able to change and adapt.

Nominations and Election of Council Members and Officers—The slate of candidates presented by the Nominating Committee was approved on a voice vote following a motion by Annette Pleshek, seconded by Scott Rickert. The Council for 2022 is:

Easter will be one service at 8am.


Worship: Pastor Jim will insert the sharing of "peace" back into the service. Peace will be done at social distancing via acknowledgement.
