In June, \$7,000 was transferred from the Dinner Theater account into the main checking. This directly increased the operating income.

For June, the general income was approximately \$900 less than general expenses without the dinner theater funds. June expenses were minimal and do not include the gas bill as it is a 10-month billing cycle.
