Director of Ministry Report January 2024

Happy New Year and continued blessings to each of you! As we welcome in the new year, let us all remember to continue to welcome Christ into our hearts and lives. Christmas isn't over yet! We continue to celebrate the birth of our Savior and the blessings he has given us. Did you know that the 12 Days of Christmas are actually the days between Christmas and Epiphany? Hopefully nobody is giving you all 12 days of gifts, like in the song. I'm pretty sure none of us needs that many birds!

As we move into a new season, we are also continuing to move forward with the shared ministry opportunity that we have mentioned over the last few months. A group of council members and myself have been meeting with a delegation from St. Luke ELCA in Sheboygan Falls to explore what a shared ministry could look like. I'm excited to say that both groups are enthusiastically working together to bring new opportunities to our congregations! We have been in close contact with a candidate that would serve both congregations. There are details yet to be worked out, and there are matters not yet totally settled, but overall we have been able to come together. The candidate is also very excited for this opportunity!

This will bring some changes to Gloria Dei, so I want to let you all know that ahead of time. This candidate will be leading worship at both churches. This likely means we will have to shift our worship time. I know that seems stressful, and we've only been back to the 9:00 service for a few months. We are working diligently to make sure we can handle this transition with as little disruption to our schedule as possible, but please understand that we will have to be flexible to some degree. The candidate will also have office hours at both churches, and will be available to us outside of those hours as well. This is NOT a called position, and the duration of this arrangement is limited. We expect that it will last about a year, perhaps a bit more.

There are many things to think about as this transition comes. One of the biggest issues we could face is finances. Our budget for this ministry will be significantly more than we have been paying for pastoral and lay ministry service up til this point. Before anyone panics, it's important to know that we CAN do this. And furthermore, it is my opinion that we NEED to do this. It will be a stretch, but Gloria Dei always finds a way! Please, please prayerfully consider this as you plan for your giving in the next year. If each household could increase their giving, even slightly, we will be ahead of the game.

On Sunday, January 7, Pastor Asher O'Callaghan and Pastor Dara Clifford from the synod office will be joining us to explain more about this opportunity and how it will benefit and enhance the ministry of Gloria Dei. They are great resources to us. They are coming to help answer questions we might have and to help us expand our thinking about how church can look. In the meantime, as questions come up for you (which I know they will!) you can feel free to reach out to me and I will do my best to answer. There are things I won't be able to answer yet, but I'll do my best and the rest we can take to Pastor Asher and Pastor Dara.

I know this feels like a lot, and honestly it is. But, Gloria Dei has always been a congregation with heart, grit, and love. This is a great time to bring those qualities to the forefront. When we work together, we can do so many things! I'm praying that this opportunity brings us so many blessings that we can hardly count them! I ask that you join me in prayer, for the candidate, for the congregation of St. Luke, and especially for Gloria Dei. Let's pray for clear discernment, a spirit of cooperation, and that all involved feel heard and seen. Again, please reach out with any questions. I'm available most readily by text, but email is also a great option. And, you could even give me a call like we did in the old days! I can't guarantee I'll be available to answer at that moment, but I will get back to you as quickly as I can. For November, the general income was approximately \$3,000 less than general expenses. We closed the Vacation Bible Camp checkbook to consolidate our accounts. Those funds are noted in the line item above.

November pastoral expenses were \$3,042 which is about \$950 more than the steady rate we had with the intentional supply pastor. December will also be increased due to addition of Wednesday Advent services. Other November expenses were \$190 snow/grass removal, \$140 for bathroom towels and business envelopes, \$52 for more bank checks, and \$35 fee to WI laboratory of hygiene. November income includes an \$11 thrivent choice deposit.

Year to date income is \$4,126 more than expenses but includes \$7,000 transferred from the dinner theater and \$1,534 transferred from Vacation Bible Camp.

Directory of Ministry Report—Our church record book of membership, baptisms, weddings, confirmations, funerals, etc. will be worked on in January 2024. The Directory will also be updated.
